## **Breeding Contract**

l,	_ (hereinafter called the "Client") hereby
request a reservation to breed the mare nam	ned below to the stallion, Salty Hobby
Boy, AQHA #3670983, standing at High Mea	dow Quarter Horses in Prospect, Nova
Scotia, on the following terms:	

- 1. The Client agrees to pay to High Meadow Quarter Horses a breeding fee of \$500.00 with one half (\$250.00) due upon delivery of the mare. The balance of the breeding fee, plus board and any other expenses (vet, farrier, etc), shall be paid to High Meadow Quarter Horses prior to the mare leaving the property of High Meadow Quarter Horses.
- 2. The board fees at High Meadow Quarter Horses will be \$8.00 per day dry (without foal at side), or \$10.00 per day wet (with foal at side). This includes hay and bedding but does not include grain.
- 3. The Client represents and warrants that the mare to be bred is halter broken, healthy and in sound breeding condition. If registered, a photocopy of the mare's papers, showing both sides, must be furnished and returned with this Contract as one of the requirements.
- 4. The Client agrees to have the mare current on worming and vaccinations before delivering the mare to High Meadow Quarter Horses.
- 5. The mare will be delivered to and left at High Meadow Quarter Horses until settled, or returned as many times as necessary during the season. All reasonable efforts will be made to settle the mare when present at High Meadow Quarter Horses.
- 6. High Meadow Quarter Horses may exercise its own judgement in caring for and supervising the mare and/or foal. The Client and the Client's veterinarian may perform at their absolute discretion such veterinarian services as they deem necessary or appropriate at the Client's expense. These include, but are not limited to, worming, treating for infections, disease or accident-related conditions, preventive measures, original examinations, artificial insemination, pregnancy checking.

- 7. High Meadow Quarter Horses and any other parties involved shall be held harmless of liability for any loss from fire or theft, sickness, disease, injury, death, or other harm suffered by the mare and/or foal. Likewise, the Client assumes no liability for injury, sickness or death of the stallion, owners, or employees caused by the mare and/or foal.
- If the mare does not settle or does not produce a "live foal" (one that stands 8. and sucks), the Client shall be entitled to return the mare, or a substitute mare, approved by High Meadow Quarter Horses, for breeding on the terms and conditions provided in this Contract, upon payment of that year's board and other expenses, but without payment for any further Breeding Fee. This obligation by High Meadow Quarter Horses to re-breed will apply only if the Client notifies High Meadow Quarter Horses within seven (7) days from the birth of a stillborn foal or within thirty (30) days of a miscarriage. This notice must be accompanied by a statement from a licensed veterinarian verifying such facts. It is agreed that this provision will be of no further effect if the mare is taken to any other stallion before returning to Salty Hobby Boy. If the Client fails to deliver the mare for re-breeding within one (1) year of notification of foal dying or miscarriage (unless special considerations have been made), any and all fees paid will be forfeited. The right to re-breed under this contract is thereby cancelled and High Meadow Quarter Horses is released from any further obligation.
- 9. If Salty Hobby Boy should die or become unfit for service before the mare produces a live foal, the Breeding Fee only shall be refunded to the Client by High Meadow Quarter Horses. Under no circumstances other than stated above shall the Breeding Fee be refunded.
- 10. High Meadow Quarter Horses reserves the right to refuse to breed any mare for any reason.
- 11. The Client hereby grants High Meadow Quarter Horses a lien upon the mare and any foal for any unpaid Breeding Fees, mare care charges, board fees, veterinarian charges, or any other charges.
- 12. The Client certifies that he/she is the sole owner of the mare or has full authority to enter into this Contract on behalf of the owner(s).
- 13. When High Meadow Quarter Horses, by its authorized representative, signs and returns a copy of this Contract to the Client, it will become the binding contract of both parties. This contract is not transferable or assignable.
